We are unable to complete this request without a Letter of Representation. Thank you for your medical records request for the patient above. We are unable to comply with your request at this time for the following reason(s). Due to the nature of the Protected Health Information, please provide a valid HIPAA Authorization signed by the patient or their personal representative and/or a court order. A HIPAA Authorization is enclosed with this letter.



Please be aware that a court order, and not a HIPAA Authorization, is necessary if the subpoena seeks any adoption-related records, to the extent any exist. If a HIPAA Authorization is provided without a court order, no adoption-related records can be produced.

Please also be aware that both the HIPAA Authorization and a court order must specifically identify the categories of Protected Health Information permitted for release. A HIPAA Authorization and/or a court order simply referring to "entire record", or similarly broad categorization, is insufficient for the records to be produced. Instead, the HIPAA Authorization and/or court order must identify and authorize with specificity all categories of information to be released.
