A new option has been added to the Search Requests screen, mainly for the Requester Support team, to filter for requests that have been sent to them with "Unknown" as the Requester Type.

Datavant Requests New Workflow - Ciox Certified Requester

Currently, requests coming from Datavant present additional address information in the Request Letter that causes confusion with Users as to who the requester actually is and where the records need to be delivered. Healthsource now has the ability to configure the 'Ciox Certified Requester' user interface (like the existing DDS behavior) for requests with electronic intake and electronic delivery based on the Requester Type and Reason for Request.

With this release, HealthSource will configure Datavant requester types with Life Sciences reason for request with this new behavior. This implementation is configurable for all Requester Type & Reason for Request combinations to support future use cases. You will only be able to see and edit specific fields in the Requester/Bill To section. The chart directly below lists the field changes, and the Request screen capture shows the changes in red.
