### Fulfilled By Me Search filter

A request search filter has been added for the CSR/Fulfillers/non-Logger roles to quickly search for the requests that they submitted from fulfillment or corresponded.

The new function filters the requests that you are the most recent person that fulfilled the request (including fulfilling from FQC, Cert, and Pend), or you corresponded.

Note: Requests that are recalled and therefore are in Ready to Fulfill status and get fulfilled by a different User than the original User are included in the original Users' search.

The filter can be used with other filter criteria fields such as Date Range, Sites, Milestone, and and/or Requester Class, etc. The current request Status displays in the far right Request Status column.

The **Me** checkbox is automatically checked when clicking Fulfilled by. The User lookup cannot be used to select another User- this functionality is only for the person who is signed into HealthSource.

### Pull List logging automation roll out

The Logging Automation feature now auto-populates the Requester (first screen) and Patient information (second screen) for Request Letters that contain a "pull list" of patients. The request is routed to Ready to Log for manual QC/review of the:

- correct Requester
- total number of patients
  - Note: Sometimes one more, or one less, patient is logged
- patient(s) data

Upon completion of the review and submission, the child requests are routed to Ready to Fulfill.

Note: When there is only one patient identified by the logging automation tool, the request is assigned a Request Type of Standard, instead of Pull List.

The patient data is auto populated but needs to be reviewed to ensure it is correct and the number of patients also needs to be reviewed. The screen below shows the Patient Information screen
