A change has been made to correct an issue with outdated address line 2 and line 3 data when using the Requester Lookup function.

Prior to this change, the previous address line 2 and/or line 3 that was in the Lawson database but had been REMOVED, still showed in the Requester Lookup results window as seen below.

In the example below the Requester had a suite of "STE 2" at one time in the past but it was since removed from address line two.

The PAYD requests have had a request **status name change** on all requests fulfilled/corresponded and are in the next stage for the Chart Finder team to process. After you fulfill/correspond a PAYD request, **you are done**. You do not need to do anything further with these requests. The only teams that need to get involved with these requests are the Chart Finder team, Price Review team, and Back Office team.

Background- There have been several changes to the PAYD back end flow over the last several releases dating back to Rel 9.0 on November 9, 2023. The main change was to the back end flow after Fulfillment/Fulfillment QC/Correspond. The change routes PAYD manual and digital requests to ChartFinder for customer/requester ID match validation before routing to the Back Office. (Prior to Nov 9, this validation was done as part of the Back Office processing.) The request Statuses for this routing are *Match in Progress* and *Match Exception* under the Fulfillment milestone which is used by the Price Review team.. In addition, two other new Statuses were originally part of the *Packaging milestone* but were found to have adverse effects on the OMAP reports. In late December, 2023, a change was



made to move these two Statuses under the *Delivery milestone* so the request would not skew the OMAP reports.


