# **New Delivery Method for CMS Contractor Requesters**

#### Introduction

Electronic Submission of Medical Documentation System (esMD) is an electronic delivery method developed by CMS to deliver medical records related to claims being audited by Medicare. Historically, esMD delivery of medical records was only available to clients that utilized Ciox's AudaPro or HIHPro applications. These clients receive audit medical record requests from Review Contractors (RC) that work with CMS, and they track the larger claim audit process there as well. Recently, it has become necessary to provide this same electronic delivery method (esMD) for Ciox's ROI client base as well.

#### **Feature Summary**

HealthSource has enabled Requester 2412975, CERT Documentation center, Contractor for esMD delivery from HealthSource. All requests *manually logged* for this Requester are delivered electronically via the Center for Medicare Services, CMS gateway (via secured record transmission).

- 1. First, the record is transmitted to CMS. An acknowledgement is sent from CMS to Ciox that states whether the record was received successfully.
- 2. CMS then routes the record to the RCs for receipt. Another acknowledgement is sent by CMS to CIOX.
- 3. The RCs then confirm receipt of the requested medical record. A third acknowledgement is sent, if successful, that the record delivery is complete.
- 4. In addition to the acknowledgements, CIOX receives a transaction ID which is used to identify the transmission if CMS needs to review or troubleshoot.

**Note:** Any record that is attempted to be sent using esMD and the record transmission has failed (i.e. api unavailable) and cannot be retried will be routed to paper.



### Frequently Asked Questions on esMD Delivery Failure

#### **Question: What if the esMD delivery fails?**

Answer: Operations need to log an ITSD ticket and specify that it is an esMD request and provide the site and invoice number or eRequest ID in the ticket.

#### Question: Who will be notified of the esMD delivery failure?

Answer: A Summary Report will be generated, and it will be routed to ASM-CRI team and the esMD support team.

#### **Question: How does ASM respond?**

Answer: The esMD support team will respond via email to the User who logged the ticket, and a FedEx tracking number will be provided if the record is mailed.

# Pull List Child Coversheet Parent eID

The Ciox generated Coversheet for a child now contains the parent eRequest ID in the top section. With HealthSource Release 5.19, 08/11/22, the parent Request Letter/Coversheet is no longer copied to each of the child requests. Instead, the child has its own Coversheet. The Parent eRequest ID was added to the child Coversheet so Users don't have to go to the History screen to get the parent eID.
